



## Mr. Daniel "Dan" D Strahm

Daniel D "Dan" Strahm, 65, of Craigville, passed away at 4:49 a.m. Sunday, April 28, 2013 at his home after a courageous battle with cancer.

Dan was born in Bluffton on September 23, 1947 to Aden Daniel and Bertha Mae (Meyer) Strahm. He married Donna G. (Sherman) on August 31, 1990 in Fort Wayne and she survives.

Dan graduated from Lancaster High School. He was a life-long resident of Wells County; living in the home place where he was born and raised. He was a service technician for McDonald's Restaurants for thirty years. He was also the owner/operator of Dan's Commercial Service Company since 2010. Dan was a U.S. Army Veteran having served our country during the Vietnam War and was a member of American Legion Post #111.
