Jack L. Barcus, 71 of Bluffton passed away at 11:35 pm Tuesday, December 2, 2014, at his residence surrounded by his family.

Mr. Barcus was born on February 26, 1943 in Wells County to Herman M. & Edith (Williamson) Barcus. He was a 1962 graduate of Liberty Center High School. He served in the Indiana National Guard for 6 years. Jack started farming at the age of 10. He was the 4th generation to farm on the family farm. He was a 47 year member of Mulberry Street Wesleyan Church and currently attended Hope Missionary Church in Bluffton.

On January 8, 1966 in Bluffton, Jack and Karen (Shane) were married at the Mulberry Street Wesleyan Church in Bluffton.

Mr. Barcus is survived by his wife Karen of Bluffton and children: Tammy (Tim) Garwood of Springfiled, IL and David (Nikki) Barcus of Poneto, IN along with six grandchildren: Melissa (Paul) Beaty of Huntington, Laura (Zach) Russell of Kansas City, MO, Kristen Garwood of Springfiled, IL and Gavin, Linden and Gideon Barcus all of Poneto, IN.

He is also survived by his mother Edith of Bluffton, a sister Janice (Floyd) Soper and a brother Jim Barcus all of Bluffton.
