



## Jane A. (Lautzenheiser) Case

August 4, 1948 - February 23, 2015

Jane A. (Lautzenheiser) Case, 66 of Bluffton, passed away at 4:50 p.m. Monday, February 23, 2015, at River Terrace Estates in Bluffton.

Jane was born on August 4, 1948 in Bluffton to William N. & Rose A. (Wahman) Lautzenheiser. She was a 1966 graduate of Bluffton High School and a member of St. Joseph Catholic Church, where she was active in St. Joseph Women's Group and the PSI IOX Sorority. 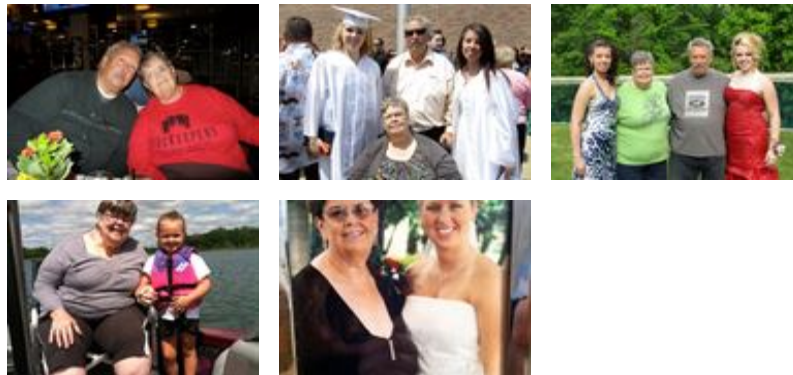
