John C. Braden, 74 of Bluffton, passed away Friday, April 9, 2021, at his home with his loving family by his side.

He was born on June 17, 1946 in Bluffton to Robert J. and Mildred P. (Ray) Braden. A 1964 graduate of Rockcreek High School, John joined the Navy and served our country in Vietnam.
