Pamela Sue Probst, 73 of Warren and formerly of Keystone, passed away on Tuesday, February 24, 2026, at her residence.

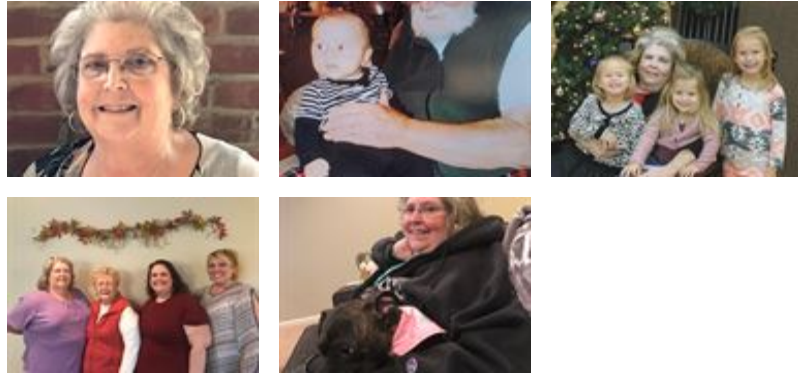
