



## Ronald L. "Ron" Langley

February 3, 1949 - January 5, 2009

Ronald L. "Ron" Langley, 59, of Bluffton, died at 4:09 P.M. Monday, January 5, 2009, at Bluffton Regional Medical Center following a battle with cancer. He had been ill since June of 2008. Mr. Langley worked as a C.F.O. and C.P.A. at Lutheran Social Services in Fort Wayne. A lifelong resident of Wells County, he graduated from Bluffton High School in 1967. He earned degrees from I.P.F.W. including an M.S. and an M.B.A. in business. He was a licensed C.P.A. and real estate broker. He was a member of the C.P.A. society and was a board member for Goodwill Industries of Fort Wayne. He enjoyed riding his Harley with his wife and friends. He was born February 3, 1949 in Kokomo. He married Janet Rose April 7, 1979, in Bluffton; his wife survives. Also surviving is his mother, Zelma Harness Langley of Bluffton; a brother, Michael Langley (wife: Cynthia) of Liberty Center; and a sister-in-law, Marilyn Langley of Leesburg, Indiana. 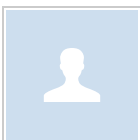
